### North Mason Regional Fire Authority (NMRFA) Meeting Minutes 460 NE Old Belfair Hwy, Belfair 3/10/2020

**Present:** Commissioners Kelley McIntosh, Brooke Quigley, Dan Kewish; Executive Assistant Wassenaar; Chief Bakken; Assistant Chief Cooper

Absent: Bob Miller, Paul Severson

Guests: None

Meeting was called to order at 5:05 p.m. and opened with the Pledge of Allegiance.

The meeting minutes from February 11 and February 18, 2020, were presented for approval.

Commissioner Kewish moved to approve the meeting minutes. Commissioner Quigley seconded the motion. Motion approved.

Financial vouchers were presented for review.

A motion was made by Commissioner Quigley to approve the payroll vouchers under BIAS 200302001 to 200302025 in the amount of \$262,035.39 and expense vouchers under BIAS 200301001 to 200301054 in the amount of \$89,488.03. Commissioner Kewish seconded the motion. Motion carried.

#### ADMINISTRATION

**Firefighter Testing Process:** Chief Bakken indicated we are currently accepting applications to create eligibility roster for entry level and lateral firefighter positions. No current openings but will test and rank up to 250 applicants to prepare for any future openings.

**Emergency Prevention Specialist Update:** Currently have 12 applications and expect several more prior to closing date of Friday February 13. Chief Bakken discussed the upcoming Assessment Center to be held on February 20.

**Leadership Academy:** Assistant Chief Cooper put together Advanced Leadership in Fire Service training conference. Attendees included roughly 40 students and almost entire command staff. 40 hours of leadership instruction provided.

#### **OLD BUSINESS**

**Bond Rating & Interest Rates for Bond Sale:** Discussed bond rating of AA- and bond sale that took place today March 10. All-time lows allowed us to lock in interest rate under 2% resulting in great savings. Chief Bakken posted update on social media and will be publishing in the newspaper shortly.

**Tahuya Fire Station Diesel Exhaust System Bid:** Bid closed with one bid received from Air Exchange, Fairfield CA in the amount of \$45,878.00. Air Exchange will purchase required equipment immediately upon receipt of Notice to Proceed and expect project completion within 5 weeks of receiving parts, not to exceed total turnaround of 12 weeks.

Motion made by Commissioner Quigley to accept and award diesel exhaust removal system bid from Air Exchange as submitted. Commissioner Kewish seconded the motion. Motion carried.

**Tahuya Fire Station Update:** Chief Bakken provided photographs and discussed status; anticipate 4-6 weeks for completion. The doors have been installed and masons are currently installing outer rock. Also discussed Reader Board Sign to be purchased by Tahuya Community Club; TCC has agreed to purchase and maintain the sign and allow NMRFA to use. Future agreement will follow.

#### **NEW BUSINESS**

**Resolution 20-04:** Authorize Mason County Treasurer to establish a Construction Fund Account for the Fire Authority. Account is specifically for construction, property acquisition, paying contractors, etc.

Motion made by Commissioner Kewish to approve Resolution 20-04. Commissioner Quigley seconded the motion. Motion carried.

#### GOOD OF THE ORDER/GENERAL DISCUSSION

Commissioner Quigley brought up public concerns regarding the safety measures being taken by first responders due to COVID19. Chief Bakken explained that we have specific COVID19 kits on all medic units; dispatch has specific protocol in place to alert responders when specific COVID19 triage criteria are met; Mason County Public Health has activated the Mason County Emergency Operations Center - Authority is currently working through the Washington Fire Chief's Association in concert with the EOC, to stay up-to-date on the latest local information distribution.

Discussed the location of next week's Commissioner meeting, as meeting is to be held in Tahuya on a quarterly basis. Due to construction nearing completion, we will be holding the second meeting in April in Tahuya.

### North Mason Regional Fire Authority (NMRFA) Meeting Minutes 460 NE Old Belfair Hwy, Belfair 3/17/2020

Meeting was called to order at 5:04 p.m. and opened with the Pledge of Allegiance.

#### ADMINISTRATION

Chief Bakken indicated we are postponing all Agenda Items until the next Commissioner Meeting in April, in order to focus on COVID-19 updates.

**Emergency Operations Center (EOC):** State of Emergency declared by Mason County on Saturday 3.14.2020 at 2:30 p.m., with intent to open Emergency Operations Center (EOC) Monday 3.23.2020, and develop Area Command over the weekend. Previously, Incident Command had been led by Mason County Public Health through Friday 3.13.2020. Area Command has been divided into functions – Chief Bakken will be leading Fire and EMS.

**Cases/Testing:** As of 3.17.2020, there are zero confirmed cases in Mason County. The virus is more than likely active in the area, but has not yet been confirmed via testing. COVID-19 Tests have been received by Mason General Hospital, but are only being provided to symptomatic patients. Belfair Urgent Care also has symptomatic testing available. NMRFA has access to tests for symptomatic Responders, should testing become necessary.

**Cancellations:** Community CPR Classes, CRT Training, outside training, portions of upcoming Fire Academy, NMRFA Dinner

**NMRFA Update:** In weeks prior, NMRFA First Responder fell ill and attempted to get tested for COVID19 through Mason County Public Health, but was unsuccessful. As a result, Responder self-quarantined at home and has since been medically cleared by his doctor; Responder will return to work next rotation. First Responders are following CDC guidelines and are not coming in when sick. Fire Stations have been

closed to the public with notification posted, including instructions on how to ensure illness is not brought into the station.

**Personal Protective Equipment (PPE):** All Fire Districts within Mason County are currently stocked with adequate PPE. Mason County has also been awarded \$500,000 from Washington State for preparation.

**Public Health:** NMRFA is notifying Public Health when in contact with someone who is potentially ill with COVID-19; Chief Bakken is finalizing plan/procedure with Public Health, to ensure that NMRFA is receiving timely updates from Public Health as well. Chief also working closely with Public Health on potential quarantine locations; this is a function of Public Health, however since they are not familiar with North Mason area, NMRFA is consulting on locations.

**Harrison Hospital:** 90% of patients transported to Harrison Hospital which is outside of Mason County (Kitsap); Chief Bakken has asked Area Command to formalize process to confirm we are receiving timely updates from Harrison or Kitsap County. Harrison Hospital is anticipating moving from Level 2 to Level 3 lockdown (no visitors including Labor and Delivery).

**Child Care:** Setting up child care locally has been slow. An estimated 40% of Harrison Hospital staff have school-aged children. If staff are unable to find appropriate child care or choose to stay home with children, there is a concern that Harrison may have to pull staff from the local clinics and provide only specific services (cancel elective procedures). North Mason Schools to provide care for all NMRFA First Responders at the HUB; anticipate opening next Wednesday 3.25.2020. Chief Bakken is also working with NMSD regarding meals for students – have identified specific pickup locations, however the turnout has not been great; will continue discussion including potential alternatives i.e. bus route.

Fire Station Cleaning: Station 21, Tahuya and Collins Lake to be sanitized next week.

**Funding:** Due to State of Emergency Declaration, NMRFA is able to recover costs associated with COVID-19 – Angie is currently tracking.

#### GOOD OF THE ORDER/GENERAL DISCUSSION

Commissioner McIntosh indicated joint Fire Commissioners meeting still scheduled for April 2; currently reaching out to other Districts to determine if it will be cancelled.

Commissioner Severson self-quarantined as he had exposure to COVID-19.

Public Comment: None

With no further business, Commissioner McIntosh adjourned the meeting at 5:40 p.m.

Guests: None

Meeting was called to order at 5:00 p.m. and opened with the Pledge of Allegiance.

Financial vouchers were presented for review. Chief Bakken addressed the amounts for S & P Global, Hill International, power gurneys and JH Kelly due to the large totals. Also discussed were the existing and potential costs for the upcoming EMS Levy renewal.

A motion was made by Commissioner Severson to approve the payroll and expense vouchers under BIAS 200401001 to 200401092 in the amount of \$901,837.07. Commissioner Kewish seconded the motion. Motion carried.

#### ADMINISTRATION

**Emergency Prevention Specialist:** Chief Bakken explained that we are still in the hiring process for the EPS position. Assessment Center was held via Zoom conference last week with multiple NMRFA members. Of the seven finalists, four have been selected for a final Chief's interview to be held this Friday or next Monday.

**Emergency Management Campus Request for Qualifications (RFQ):** Commissioner Severson requested we add an addendum, if necessary, indicating that any public opening will be held via Zoom due to the existing stay at home order. Also indicated the RFQ is published on ConstructConnect and Planwell with a project budget/scope of \$60,000. Executive Assistant Wassenaar indicated she will look into both concerns and provide an update at the next meeting.

**COVID-19:** Chief Bakken provided an update on the impact of COVID-19

*EMS Response Procedure*: Walked through the existing response procedure when respiratory illness is suspected or when COVID19 has been confirmed within the residence.

EMS Call Volume: Have seen a decrease of 20-25% in call volume.

*Shelton Journal*: Lieutenant Laura Chester drafted an article for the Journal addressing concerns regarding public safety and first responders during the pandemic – to be published this week.

Area Command: Brief update on Area Command and distribution of information to the public.

Personal Protective Equipment: Supply is adequate both within the County as well as region.

*COVID-Related Expenses*: Overall cost to the Fire Authority has been low; tracking any expenses for future reimbursement.

*Re-Opening*: No formal plan has been devised; anticipate a systematic format based on data. There is no indication all business will be open as of May 5; rather, open specific trades and weigh the impact before opening others.

Serum Testing: Not currently available in Mason County.

Station Cleaning Plan: Assistant Chief Cooper established a cooperative cleaning plan with North Mason Schools to utilize their janitorial staff to clean stations at a fraction of the cost of other professional cleaning businesses. This not only saves the Authority money due to the reduced cost, but also provides NMSD with work and funds. Station 21 has been completely cleaned/disinfected – Stations 27 and 81 are in process.

#### **NEW BUSINESS**

**Resolution 20-05:** Provide for the submission to qualified electors of the North Mason Regional Fire Authority at an election to be held on August 4, 2020, Proposition authorizing the continuation of an Emergency Medical Services property tax levy not to exceed \$.50 per \$1,000.00 of true and assessed valuation, in addition to its regular property tax levy, for a period of six consecutive years beginning in 2020 and ending in 2025 and to be collected in each succeeding year (2021-2026) to provide funds required by the Fire Authority to enable the Fire Authority to provide Emergency Medical Services.

Discussed the language in the Resolution drafted by Attorney Brian Snure. Two options were provided for ballot language, which were discussed at length. Chief Bakken indicated that following Board approval, the Mason County Prosecutor's Office will also need to approve the language. Board requested additional options be provided that make the language more clear to voters. Chief will modify language and send to Board prior to the next meeting scheduled for April 21.

#### GOOD OF THE ORDER/GENERAL DISCUSSION

COVID testing sites throughout Kitsap County were discussed. The Fire Authority has not utilized these sites at this time because they send out to private labs which currently have a longer turnaround time.

### North Mason Regional Fire Authority (NMRFA) Meeting Minutes Via Telephone/Videoconference 4/21/2020

**Present:** Commissioners Kelley McIntosh, Brooke Quigley, Dan Kewish, Bob Miller, Paul Severson; Executive Assistant Wassenaar; Chief Bakken; Assistant Chief Cooper

Meeting held via telephone/videoconference in accordance with Governor Jay Inslee's proclamation 20-28 issued on March 24, 2020

Absent: None

Guests: None

Meeting was called to order at 5:04 p.m. and opened with the Pledge of Allegiance.

#### ADMINISTRATION

**Emergency Prevention Specialist:** Final interviews have taken place and Lacey Newman has been selected for the position. Due to the pandemic and stay at home order, she does not have an anticipated start date at this time; however, she has verbally accepted and an offer letter will be sent shortly.

**Firefighter Testing:** Online testing took place over the weekend and we have received scores for all applicants. Overall, the applicants did very well, with the nearly all scoring over 85. Panel interviews with NMRFA members scheduled for this coming Thursday (via telephone/videoconference).

**Student Firefighters:** We have received 10 applications for the Student Firefighter Program. Captain Reese is currently reviewing the applications and will be setting up interviews (to be held via telephone/videoconference).

**COVID-19 Update:** There are currently 22 positive cases in Mason County as of last Friday; no new cases reported since. Discussed the pressure of re-opening businesses in comparison to what is medically suitable. Chief Bakken indicated as of Friday he will no longer be the liaison for Area Command, as Lieutenant Fulkerson will be taking over (anticipating for the next three weeks).

#### Cancellations:

<u>CAC Meeting</u> has been postponed until further notice <u>Tahuya Days/Salmon Bake</u> – Commissioner Quigley received an email from Tahuya Community Club cancelling both events. Chief Bakken had not received any notification but will look into it <u>Retention Committee</u> – Commissioner Severson advised meeting has been cancelled. Also wanted to address the recent resignation of three NMRFA staff members; no indication this is related to any happenings within the Authority, rather appear to be based on personal reasons.

**Safety Days:** Chief Bakken provided an update; Team has been developed to plan Safety Days – anticipate moving to an electronic platform. New Emergency Prevention Specialist Lacey Newman will be a part of that project.

**Emergency Management Campus RFQ:** Executive Assistant Wassenaar provided an update on the RFQ – confirmed electronic/telephonic instructions were built into the RFQ for any potential site walk through and interviewing processes. Also confirmed that she spoke with Chuck from Hill International, who contacted ConstructConnect to correct the project scope/budget of \$60,000. Additionally, indicated scope/budget was not included in the RFQ or any formal advertisement issued by the Authority.

#### **NEW BUSINESS**

**Resolution 20-05:** Provide for the submission to qualified electors of the North Mason Regional Fire Authority at an election to be held on August 4, 2020, Proposition authorizing the continuation of an Emergency Medical Services property tax levy not to exceed \$.50 per \$1,000.00 of true and assessed valuation, in addition to its regular property tax levy, for a period of six consecutive years beginning in 2020 and ending in 2025 and to be collected in each succeeding year (2021-2026) to provide funds required by the Fire Authority to enable the Fire Authority to provide Emergency Medical Services.

Chief Bakken provided multiple options for ballot language as requested for Board review. Following lengthy discussion, the Board agreed upon 4A:

Will North Mason Regional Fire Authority be authorized to continue to fund emergency medical services for its citizens by continuing to impose a regular property tax levy of \$.41 or less per \$1,000.00 of assessed valuation (subject to the existing voter approved maximum of \$.50) for a period of six consecutive years to be collected beginning in 2021?

Motion made by Commissioner Severson to approve Resolution 20-05. Commissioner Quigley seconded the motion. Motion carried.

#### GOOD OF THE ORDER/GENERAL DISCUSSION

*House Fire off Highway* 106 – Suspected that fire started in the garage and quickly spread. Multiple departments responded with over 30 firefighters on-site for over 6 hours. DNR also responded with water dropping helicopter, as fire caused multiple brush fires. No major injuries reported; one bystander that was knocking on doors transported for smoke inhalation. Captain Ehresman injured his thumb but was unable to get evaluated until today due to limited medical services being available at this time – they will know more after he has an MRI.

*Brush Fires* – Multiple fires throughout Mason County, with many starting as burn piles that got out of hand. Because of the recent dry weather, have already begun discussions with Department of Community Development concerning increasing burn restrictions. Plan to re-evaluate on May 1.

*Private Bridges* – Coulter Creek Fire result of unpermitted fire that got away from the homeowner. Access was limited to a personal/private bridge which homeowner indicated would support a fire engine. When Authority personnel drove over the bridge, it partially gave way. Fire Engine was freed after nearly four hours and was able to drive back to the station – currently assessing damage. Authority will be working with EF Recovery to bill the homeowner for the response as well as any damage to the engine.

Chief indicated there are roughly 35 private/personal bridges within the response area (identified on GIS map); need to create a Policy to address how we will evaluate these bridges, determine if we will cross them (and what to do if not), responsibilities of the homeowners etc. We have previously attempted to have a third party evaluate local bridges but have been unable to reach the evaluator since. Jeromy Hicks had also evaluated bridges and identified multiple that NMRFA vehicles are not to cross, however that was five or more years ago.

Group discussed Central Kitsap's policy requiring homeowners to obtain engineering certification (which can be incredibly expensive); if not approved CK will not respond over bridge – multiple concerns with implementing a policy that extreme due to the impact on the homeowner. Further discussion required.

## NORTH MASON REGIONAL FIRE AUTHORITY RESOLUTION 20-06

# A RESOLUTION OF THE NORTH MASON REGIONAL FIRE AUTHORITY BOARD OF FIRE COMMISSIONERS TO AUTHORIZE THE USE OF ELECTRONIC SIGNATURES WITH THE SAME FORCE AND EFFECT AS THE USE OF A SIGNATURE AFFIXED BY HAND

**WHEREAS**, the term "electronic signature" is defined in RCW 19.360.030 as an electronic sound, symbol or process attached to or logically associated with a contract or other record and executed or adopted by a person with the intent to sign the record; and

**WHEREAS,** RCW 19.360.010 specifically provides that "the legislature, to the extent not already authorized by federal or state law, authorizes electronic dealings for governmental affairs" and "intends to promote electronic transactions and remove barriers that might prevent electronic transactions with governmental entities;" and

**WHEREAS**, RCW 19.360.020(1) provides that "an electronic signature may be used with the same force and effect as the use of a signature affixed by hand, as long as the electronic signature conforms to the definition in RCW 19.360.030 and the writing conforms to RCW 19.360.040;"

**WHEREAS**, Engrossed Substitute Senate Bill 6028, Uniform Electronic Transactions Act provides that "if a law requires a signature, an electronic signature satisfies the law;" and

**WHEREAS**, the use of electronic signatures for Authority documents and to conduct Authority business, where appropriate and permitted by law, will lessen administrative demands, improve efficiency, increase access to public information and provide for predictable processes throughout the Authority;

# NOW THEREFORE, THE NORTH MASON REGIONAL FIRE AUTHORITY BOARD OF FIRE COMMISSIONERS DOES RESOLVE AS FOLLOWS:

1.1. The Authority employee is authorized by the Board of Fire Commissioners or the Fire Chief to sign the document;

1.2. The process employed for the electronic signature provides for security, authentication, record integrity and non-repudiation of the electronic communication.

Section 2. The following electronic signature types are authorized for use:

- 2.1. A digital object indication approval or authorization (such as signature image).
- 2.2. Use of a third-party electronic signature service (such as DocuSign).
- 2.3. Use of a third-party electronic signature service which has been licensed as a certification authority (CA) by the Washington Secretary of State.

Section 3. An electronically signed document shall be deemed the equivalent of an original signed document if the individual or entity signing the document has complied with the provisions of this Resolution.

### SCOPE

All Authority personnel and Board of Fire Commissioners.

### PURPOSE

The policy of the Fire Authority is to enable employees to conduct Authority business through the use of electronic signatures where desired, when such use is consistent with these guidelines. All Authority employees who utilize electronic signatures in the conduct of their duties will have reviewed these polices to ensure that, to the best of their ability, the guidelines herein are followed. Electronic signatures consistent with this policy may be used by the Authority in the same way that physical signatures may be used. Authority staff may rely on electronic signatures which are consistent with this policy in the same way staff relies on physical signatures.

## POLICY

- 1. Definitions. Electronic signatures include an electronic sound, symbol or process.
  - 1.1. A variety of digital objects may serve as an electronic signature.
  - 1.2. The electronic signature must clearly be associated with the related paper or process intended to be attested to.
  - 1.3. The signature must be verifiable as part of the underlying record.
  - 1.4. The signature must have been executed or adopted by a person with intent to sign the record as appropriate based on the nature of the document.
- 2. Authorized Use. The North Mason Regional Fire Authority Fire Chief, Assistant Fire Chief, Executive Assistant(s) and any employees who are designated by the Board of Fire Commissioners or Fire Chief to sign Authority documents or conduct official public business may do so electronically if such an option is available, provided the following:
  - 2.1. The Authority employee is authorized by the Board of Fire Commissioners or the Fire Chief to sign the document;

- 2.2. The process employed for the electronic signature provides for security, authentication, record integrity and non-repudiation of the electronic communication.
- **3.** Acceptable Forms of Electronic Signatures. The following electronic signature types are authorized for use:
  - 3.1. A digital object indication approval or authorization (such as signature image).
  - 3.2. Use of a third-party electronic signature service (such as DocuSign).
  - 3.3. Use of a third-party electronic signature service which has been licensed as a certification authority (CA) by the Washington Secretary of State.
- **4. Legal Recognition**. In accordance with the Uniform Electronic Transactions Act ESSB 6028, a record or signature may not be denied legal effect or enforceability solely because it is in electronic form.
  - 4.1. If a law requires a signature, an electronic signature satisfies the law.
  - 4.2. If a law requires a signature or record to be notarized, acknowledged, verified or made under oath, the requirement is satisfied if the electronic signature of the person authorized to perform those acts, together with all other information required to be included by other applicable law, is attached to or logically associated with the signature or record.

#### Note 1 - Summary of Significant Accounting Policies

The North Mason Regional Fire Authority was incorporated on January 1, 2014 and operates under the laws of the state of Washington applicable to a Fire Authority. The Authority is a special purpose local government and provides fire protection and emergency medical services to the local public.

The Authority reports financial activity in accordance with the *Cash Basis Budgeting, Accounting and Reporting System* (BARS) Manual prescribed by the State Auditor's Office under the authority of Washington State law, Chapter <u>43.09</u> RCW. This manual prescribes a financial reporting framework that differs from generally accepted accounting principles (GAAP) in the following manner:

- Financial transactions are recognized on a cash basis of accounting as described below.
- Component units are required to be disclosed, but are not included in the financial statements.
- Government-wide statements, as defined in GAAP, are not presented.
- All funds are presented, rather than a focus on major funds.
- The *Schedule of Liabilities* is required to be presented with the financial statements as supplementary information.
- Supplementary information required by GAAP is not presented.
- Ending balances are not presented using the classifications defined in GAAP.

#### A. Fund Accounting

Financial transactions of the government are reported in individual funds. Each fund uses a separate set of self-balancing accounts that comprises its cash and investments, revenues and expenditures. The government's resources are allocated to and accounted for in individual funds depending on their intended purpose. Each fund is reported as a separate column in the financial statements, except for fiduciary funds, which are presented by fund types. The following fund types are used:

#### GOVERNMENTAL FUND TYPES:

#### General Fund

This fund is the primary operating fund of the government. It accounts for all financial resources except those required or elected to be accounted for in another fund.

#### B. Basis of Accounting and Measurement Focus

Financial statements are prepared using the cash basis of accounting and measurement focus. Revenues are recognized when cash is received and expenditures are recognized when paid.

In accordance with state law the Authority also recognizes expenditures paid during twenty days after the close of the fiscal year for claims incurred during the previous period.

#### C. Cash and Investments

See Note 3 - Deposits and Investments.

#### D. <u>Capital Assets</u>

Capital assets are assets with an initial individual cost of more than \$5000 and an estimated useful life in excess of 1 year. Capital assets and inventory are recorded as capital expenditures when purchased.

#### E. <u>Compensated Absences</u>

Vacation leave may be accumulated up to any amount. We only payout a maximum of 240 hours, payable upon permanent separation (resignation, retirement, layoff, discharge, death). Employees may earn compensation time in lieu of overtime pay at a rate of 1 ½ hours per 1 hour worked. Employees cannot exceed 480 hours of accrued compensation leave. Compensation leave hours up to 480 are paid out upon permanent separation. Sick leave may be accumulated up 1300 hours for union employees and 1200 for administrative staff. One quarter (1/4) of sick leave accrued is paid to an employee upon retirement. Sick leave may accrue to a maximum of 1072 hours for both the Fire Chief and Assistant Chief. Upon separation from the Authority, the Fire Chief and Assistant Chief receive payment for ½ of unused sick leave. Payments are recognized as expenditures when paid.

#### REPORTING

#### Note 2 – Budget Compliance

A. <u>Budgets</u>

The North Mason Regional Fire Authority adopts annual appropriated budgets for one\_fund. These budgets are appropriated at the fund level. The budget constitutes the legal authority for expenditures at that level. Annual appropriations for these funds lapse at the fiscal year end.

Annual appropriated budgets are adopted on the same basis of accounting as used for financial reporting.

The appropriated and actual expenditures for the legally adopted budgets were as follow:

Budgeted amounts are authorized to be transferred between object classes within departments; however, any revisions that alter the total expenditures of a fund, or that affect the number of authorized employee positions, salary ranges, hours, or other conditions of employment must be approved by the Authority's legislative body.

#### Note 3 – Deposits and Investments

Investments are reported at original costs. Deposits and investments by type at December 31, 2019 are as follows:

It is the Authority's policy to invest all temporary cash surpluses. The interest on these investments is prorated to the various funds. The Authority is a voluntary participant in the Local Government Investment Pool, an external investment pool operated by the Washington State Treasurer. The pool is not rated and not registered with SCC. Rather, oversight is provided by the State Finance Committee in accordance with Chapter 43.250RCW. Investments in the LGIP are reported at amortized cost, which is the same as the value of the pool per share. The LGIP does not impose any restrictions on participant withdrawals.

The Office of the State Treasurer prepares a stand-alone financial report for the pool. A copy of the report is available from The Office of the State Treasurer, PO Box 40200, Olympia, WA 98504-0200, online at www.tre.wa.gov.

#### Note 4 – OPEB Plans

The LEOFF 1 Retiree Medical Plan is a closed, single-employer, defined-benefit OPEB plan administered by the North Mason Regional Fire Authority as required by the State of Washington. The plan pays for 100% of eligible retirees' healthcare costs on a pay-as-you-go basis. As of December 31, 2019, the plan had 1 member. That member is retired. As of December 31, 2019, The Fire Authority's total OPEB liability was \$546,405 as calculated using the alternative measurement method. For the year ended December 31, 2019, the Authority paid \$7029.93 in benefits.

#### Note 5 - Other Disclosures

#### A. Subsequent Event

On November 5, 2019, voters in the North Mason Regional Fire Authority approved the issuance of \$10,000,000 of General Obligation Bonds, maturing within 25 years to construct a new headquarters fire station as part of the new North Mason Emergency Management Campus.

On March 4, 2020, the Authority received a credit rating of AA- from S&P Global Ratings for its public bond issuance. The Authority held a public bond sale on March 10, 2020. Proceeds from the bond sale (\$10,019,450) were received by the Authority on March 31, 2020.

#### **B.** Construction Commitment

The Authority has an active construction project as of December 31, 2019. The project is: construction of the Tahuya Fire Station.

#### Note 6 – Pension Plans

#### A. <u>State Sponsored Pension Plans</u>

Substantially all of the Authority's full-time and qualifying part-time employees participate in the following statewide retirement systems administered by the Washington State Department of Retirement Systems (DRS), under cost-sharing, multiple-employer public employee defined benefit and defined contribution retirement plans: LEOFF 1, LEOFF 2, and PERS 2.

The State Legislature establishes, and amends, laws pertaining to the creation and administration of all public retirement systems.

The Department of Retirement Systems, a department within the primary government of the State of Washington, issues a publicly available comprehensive annual financial report (CAFR) that includes financial statements and required supplementary information for each plan. The DRS CAFR may be obtained by writing to:

The Authority\_also participates in the Volunteer Fire Fighters' and Reserve Officers' Relief and Pension Fund (VFFRPF) administered by the State Board for Volunteer Fire Fighters and Reserve Officers. Detailed information about the plan is included in the State of Washington CAFR available from the Office of Financial Management website at www.ofm.wa.gov.

#### LEOFF Plan 1

The Authority also participates in LEOFF Plan 1. The Authority has one participant in the LEOFF Plan 1. The LEOFF Plan 1 is fully funded and no further employer contributions have been required since June 2000. If the plan becomes underfunded, funding of the remaining liability will require new legislation. Starting on July 1, 2000, employers and employees contribute zero percent.

#### LEOFF Plan 2

The Authority also participates in the LEOFF Plan 2. The Legislature, by means of a special funding arrangement, appropriates money from the state general fund to supplement the current service liability and fund the prior service costs of Plan 2 in accordance with the recommendations of the Pension Funding Council and the LEOFF Plan 2 Retirement Board. This special funding situation is not mandated by the state constitution and could be changed by statute.

#### Note 7 - Property Tax

The county treasurer acts as an agent to collect property tax levied in the county for all taxing authorities. Collections are distributed at the end of each month.

Property tax revenues are recognized when cash is received by the Authority. Delinquent taxes are considered fully collectible because a lien affixes to the property after tax is levied.

The Authority's regular expense levy for the year 2019 was \$1.3147950 per \$1,000 on an assessed valuation of \$1,790,121,222 for a total regular levy of \$2,353,642.91.

The Authority's regular EMS levy for the year 2019 was \$0.4406630 per \$1,000 on an assessed valuation of \$1,837,495,760 for a total regular levy of \$809,717.04.

#### <u>Note 8 – Risk Management</u>

The Authority purchases an insurance coverage policy through VFIS. The policy provides risk management and coverage for auto, crime, property, portable equipment, health care liability, general liability, management liability, and excess liability. Excess liability coverage provides maximum coverage of \$6,000,000 per occurrence and \$12,000,000 annual aggregate.

The Authority makes health care, dental, vision and life insurance coverage available for all employees through the Washington State Counties Insurance Fund. The Authority also provides an HRA for all Employees. The Authority does not cover any employee health care, dental or vision costs which may

not be covered by insurance or other health care cost coverage arrangement (HRA, additional insurance).

The Authority self-insures its unemployment compensation risk on a reimbursable basis with the Washington State Employment Security Department, which acts as a third-party administrator. The District had no claims for unemployment in 2019.

## **RESOLUTION NO. 19-01**

A RESOLUTION of the Governing Board of North Mason Regional Fire Authority, Mason and Kitsap Counties, Washington, providing for the submission to the voters of the Authority at a special election to be held on November 5, 2019, in conjunction with the State General election to be held on the same date, of a proposition authorizing the Authority to issue general obligation bonds in the aggregate principal amount of no more than \$10,000,000 for the purpose of paying costs of constructing a new Headquarters Station as part of the new Emergency Management Campus, the principal of and interest on the bonds to be payable from annual excess property tax levies; designating the Fire Chief and bond counsel to receive notice of ballot title from the Auditor; and providing for related matters.

BE IT RESOLVED BY THE GOVERNING BOARD OF NORTH MASON REGIONAL FIRE AUTHORITY, MASON AND KITSAP COUNTIES, WASHINGTON, as follows:

<u>Section 1.</u> <u>Findings and Determinations</u>. The Governing Board (the "Board") of North Mason Regional Fire Authority, Mason and Kitsap Counties, Washington (the "Authority"), takes note of the following facts and makes the following findings and determinations:

(a) The Authority's expanded service area, continually increasing call volumes, the need to provide appropriate facilities for additional daytime emergency and support personnel, overnight response personnel and daily training and emergency response preparation for the protection of public health, life and property, and the old headquarters station's inadequate size and outdated facilities, require the Authority to: construct and equip a new Headquarters Station as part of the new Emergency Management Campus to serve the North Mason community's current and future emergency services needs, all as more particularly defined and described in Section 2 (the "Project").

(b) The Authority lacks sufficient money to pay costs of the Project.

(c) To pay costs of the Project, it is necessary and advisable that the Authority issue and sell unlimited tax general obligation bonds in the aggregate principal amount of no more than \$10,000,000 (the "Bonds"), or such lesser maximum amount as may be legally issued under the laws governing the limitation of indebtedness or required to carry out and accomplish the Project. (d) Pursuant to Article VII, Section 2(b) and Article VIII, Section 6 of the Washington Constitution and the laws of the State of Washington, including without limitation Revised Code of Washington ("RCW") 39.36.050, RCW 52.26.130 and RCW 84.52.056, the Authority may submit to its voters at a special election, for their approval or rejection, a proposition authorizing the Authority to issue the Bonds to pay costs of the Project and to levy annual excess property taxes in amounts sufficient to pay principal of and interest on the Bonds when due (*i.e.*, repay the Bonds).

(e) The best interests of the Authority and its residents require the Authority to carry out and accomplish the Project.

<u>Section 2</u>. <u>Description of the Project</u>. The Project to be paid for with proceeds of the Bonds, including interest earnings thereon ("Bond Proceeds"), is more particularly defined and described as follows:

(a) Construct a new Headquarters Station as part of the new Emergency Management Campus to serve the North Mason community's current and future emergency services needs, all as determined necessary and advisable by the Board.

(b) Acquire land adjacent to the old headquarters station (or at such other location as may be determined by the Board) as a site for the new Headquarters Station, all as determined necessary and advisable by the Board. The term "land" includes all real property and improvements and other structures thereon and all interests therein.

(c) Make other capital improvements for emergency services purposes, all as determined necessary and advisable by the Board.

(d) Acquire, construct and install all necessary furniture, equipment, apparatus, accessories, fixtures and appurtenances in or for the foregoing, all as determined necessary and advisable by the Board.

(e) Pay incidental costs incurred in connection with carrying out and accomplishing the Project described above under RCW 52.26.130 and RCW 39.46.070. Incidental costs constitute a part of the Project and include without limitation: (1) costs related to the issuance, sale and delivery of the Bonds; (2) payments for fiscal and legal costs; (3) costs of obtaining ratings and bond insurance; (4) costs of printing, advertising, establishing and funding accounts; (5) payment of interest due on the Bonds for up to six months after completion of construction; (6) necessary and related engineering, architectural, planning, consulting, inspection, permitting and testing costs; (7) administrative and relocation costs; (8) site assessment, acquisition and improvement costs; (9) demolition costs; (10) costs related to demolition and/or deconstruction of existing facilities to recycle, reclaim and repurpose such facilities and/or building materials; (11) costs of on-site and offsite utilities and road improvements; and (12) costs of other similar activities or purposes, all as determined necessary and advisable by the Board. The Authority is authorized to accomplish the Project, or any parts, insofar as is practicable with available Bond Proceeds, and the Board shall allocate the Bond Proceeds, together with any other money of the Authority legally available, between the various parts of the Project so as to accomplish, as near as may be, all of the Project. The Board shall determine the time, order, extent and specifications for the Project. The Project is to be more fully described in the plans and specifications to be on file with the Authority.

# Section 3. Calling of Election.

(a) The Auditor of Mason County, Washington, as *ex officio* Supervisor of Elections (the "Auditor"), is requested to call and conduct a special election, in the manner provided by law, to be held in the Authority on November 5, 2019 (the "Special Election"), in conjunction with the State General election to be held on the same date, for the purpose of submitting to the Authority's voters, for their approval or rejection, the proposition authorizing the Authority to issue the Bonds to pay costs of the Project and to levy annual excess property taxes to repay the Bonds.

(b) If the proposition is approved by the requisite number of voters, the Authority will be authorized to issue, sell and deliver the Bonds in the manner described in this resolution, spend the Bond Proceeds to pay costs of the Project and levy annual excess property taxes to repay the Bonds. The Bond Proceeds may be used, either with or without additional money now or at any time available to the Authority, for capital purposes only, as permitted by law, excluding the replacement of equipment.

# Section 4. Authorization to Issue the Bonds.

(a) The Authority may issue the Bonds as a single bond, as a single issue, as a part of a combined issue with other authorized bonds or in more than one series, all as determined necessary and advisable by the Board and as permitted by law. The Authority may issue the Bonds, as determined necessary and advisable by the Board, as taxable bonds, tax-exempt bonds or any other type of bonds that are now or in the future may be authorized under applicable state and federal law.

(b) The Bonds will be issued as fully registered bonds; bear interest payable as permitted by law; mature within 25 years from the date of issuance (but may mature at an earlier date or dates as fixed by the Board); be paid by annual property tax levies sufficient in amount to pay both principal and interest when due, which annual property tax levies will be made in excess of regular property tax levies without limitation as to rate or amount; and be issued and sold in the manner, times and amounts required for the purpose for which the Bonds are to be issued, all as determined necessary and advisable by the Board and as permitted by law. The life of the Project to be financed with Bond Proceeds will as near as practicable or as otherwise required by law exceed the term of the respective Bonds that finance the Project. The amount, date, denominations, interest rates, payment dates, final maturity, redemption rights, price, and other parameters, terms and conditions of the Bonds will be fixed by one or more resolutions of the Board authorizing the issuance, sale and delivery of the Bonds, which resolutions may delegate to an Authority officer or employee the authority to fix any of the foregoing, all as determined necessary and advisable by the Board and as permitted by law.

(c) Pending the issuance of any series of the Bonds, the Authority may levy excess property taxes to repay those Bonds and may issue short-term obligations pursuant to chapter 39.50 RCW to pay for any portion of the costs of the Project. The short-term obligations may be paid or refunded with Bond Proceeds.

<u>Section 5.</u> <u>Intent to Reimburse</u>. To the extent the Authority makes capital expenditures for the Project prior to the date the Authority issues the Bonds or other short-term obligations to finance the Project from funds that are not (and are not reasonably expected to be) reserved, allocated on a long-term basis or otherwise set aside by the Authority under its existing and reasonably foreseeable budgetary and financial circumstances to pay costs of the Project, the Board declares those capital expenditures are intended to be reimbursed out of Bond Proceeds, or proceeds of other bonds or obligations, issued in an amount not to exceed the principal amount of the Bonds provided by this resolution.

<u>Section 6.</u> <u>Sufficiency of Bond Proceeds</u>. If Bond Proceeds are more than sufficient to carry out and accomplish the Project, the Authority may use those excess Bond Proceeds to: (a) acquire, construct, remodel, renovate, install, equip, furnish and make other capital improvements to Authority facilities for emergency services purposes; or (b) retire and/or defease a portion of the Bonds or other outstanding bonds of the Authority, all as the Board may determine necessary or advisable and as permitted by law. In the event the Bond Proceeds, together with any other money of the Authority legally available, are insufficient to carry out and accomplish all of the Project, the Authority may use the Bond Proceeds and other available money for paying the cost of any parts of the Project the Board determines most necessary and in the best interests of the Authority.

<u>Section 7.</u> <u>Alteration of Expenditures</u>. If the Board subsequently determines circumstances (including without limitation changed conditions or needs, regulatory considerations or incompatible development) require alterations to the Project, the Authority will not be required to accomplish all of the Project and may apply the Bond Proceeds (or any portion) to: (a) parts of the Project; (b) the acquisition, construction, installation, equipping and making of other capital improvements to other Authority facilities for emergency services purposes; or (c) the retirement and/or defeasance of all or a portion of the Bonds or other outstanding bonds of the Authority, all as determined necessary or advisable by the Board and as permitted by law.

<u>Section 8</u>. Form of Ballot Title. Pursuant to RCW 29A.36.071, the Mason County Prosecuting Attorney, as the prosecuting attorney of the county within which the majority area of the Authority is located, is requested to prepare the concise description of the aforesaid proposition for the ballot title in substantially the following form:

The Fire Chief of the Authority (the "Fire Chief") or his or her designee is authorized and directed to: (a) present a certified copy of this resolution to the Auditor and the Auditor of Kitsap County, Washington, no later than August 6, 2019; and (b) perform such other duties as are necessary or required by law to submit to the Authority's voters at the Special Election, for their approval or rejection, the proposition authorizing the Authority to issue the Bonds to pay costs of the Project and to levy annual excess property taxes to repay the Bonds.

<u>Section 10.</u> <u>Notices Relating to Ballot Title</u>. For purposes of receiving notice of the exact language of the ballot title required by RCW 29A.36.080, the Board hereby designates (a) the Fire Chief (Beau Bakken), telephone: 360.275.6711; fax: 360.275.6224; email: <u>bbakken@northmasonrfa.com</u>; and (b) bond counsel, Foster Pepper PLLC (Lee Marchisio), telephone: 206.447.6264; fax: 206.749.2138; email: <u>lee.marchisio@foster.com</u>, as the individuals to whom the Auditor and the Auditor of Kitsap County, Washington, shall provide such notice. The Fire Chief is authorized to approve changes to the ballot title, if any, determined necessary by the Auditor or the Mason County Prosecuting Attorney.

<u>Section 11</u>. <u>General Authorization and Ratification of Prior Acts</u>. The Fire Chief, the Secretary, the Chair of the Board, other appropriate officers of the Authority and bond counsel, Foster Pepper PLLC, are severally authorized and directed to take any action and to execute any document as in their judgment may be necessary or desirable to effectuate the provisions of this resolution. All actions taken prior to the effective date of this resolution in furtherance of and not inconsistent with the provisions of this resolution are ratified and confirmed in all respects.

<u>Section 12</u>. <u>Severability</u>. If a court of competent jurisdiction, all appeals having been exhausted or all appeal periods having run, holds any provision of this resolution invalid or unenforceable, then the offending provision is null and void, is separate and severable from the remaining provisions of this resolution and in no way affects the validity of the other provisions of this resolution, of the Bonds or of the levy or collection of the taxes pledged to repay the Bonds.

Section 13. Effective Date. This resolution takes effect from and after its adoption.



# SCOPE

All department personnel

# PURPOSE

Washington State Law requires the deposit of all cash and cash like items (checks, money orders, etc.) to be deposited within 24 hours of receipt of the monies. In accordance with the state's Budgeting, Accounting and Reporting (BARS) Manual and to comply with these requirements, the following procedures have been established.

#### PROCEDURE

- 1. Receipting of cash, check, money order, etc. are recorded on a pre-numbered and imprinted receipt book with North Mason RFA name, address and phone number on the receipt.
- 2. Receipting of cash, check, money order, etc. is designated and assigned to administrative staff by the Fire Chief.
- 3. Only administrative staff should accept and receipt for cash, check, money orders, etc. All other members shall direct individuals wishing to pay or donate any and all funds to the administrative staff.
  - a. If a member of the Fire Authority finds themselves in possession of cash, checks, money order, etc. they shall place the funds in a sealed envelope, provide the information on a receipt as noted in item 5 of this document and place the envelope in the Executive Assistants office (if door is closed and locked, envelope should be slid completely under the door).
- 4. Receipts: The pre-numbered receipt forms include the following:
  - Date
  - Received From
  - Address
  - Dollars \$
  - For
  - A mode of payment (cash, check etc.)
  - Name of employee who received the funds and prepared the receipt
- 5. If the receipt is voided the original and any copies of the receipt must be retained.

# INTERNAL CONTROLS

1. The following internal controls enable the North Mason Regional Fire Authority to properly account for and safeguard cash receipts;

- Funds received in the form of checks, cash, and money order etc. in person and via the US Mail are receipted and recorded by the administrative staff.
- The receipt and funds are forwarded to the Executive Assistant for deposit to the Mason County Treasurer.
- Deposit and receipts of funds are reviewed by the Executive Assistant, the Fire Chief and the Board of Commissioners
  - Deposits and receipts are made available for the Fire Commissioners inspection.
- The funds are reconciled using the County financial reports in conjunction with the Fire Authorities records.

#### SCOPE

All Authority personnel

#### PURPOSE

The NMRFA provides emergency medical services for residents and visitors that include basic and advanced life support treatment and transport. The NMRFA utilizes a combination of tax revenue and user fees to be able to maintain service delivery. The NMRFA will have a system in place to accurately track and audit billing procedures to ensure that all emergency medical services are appropriately billed for. Responsibility and oversight for meeting this purpose involves emergency care providers, office staff, county and billing agency staff.

# PROCEDURE

- 1. After each transport is completed the attending EMS care provider (Paramedic, EMT) will be responsible to collect available patient information for billing purposes including patient signatures necessary to the billing process. A copy of the patient demographic will also be obtained from the receiving facility.
- 2. The treating provider is responsible to submit to the NMRFA's Administrative Assistant a completed Medical Incident Report and patient billing information prior to the end of the shift period.
- 3. The Administrative Assistant will prepare and send the necessary patient information to the billing agency in a timely manner.
- 4. The Billing Agency will set up an account with appropriate charges within five days of receipt of the patient information. Once the account has been established all charges with sufficient billing information are billed directly to the insurance company.
- 5. On accounts that lack sufficient insurance information a bill will be sent directly to the patient along with a form requesting insurance information. In addition the billing agency will also make efforts to acquire necessary billing information from other sources including the receiving hospital.

- 6. All patient billing inquiries will be directed to the billing agency via a toll free phone number. All the employees of the billing agency will be cross trained as to be able to handle patient's questions without forwarding the call to someone else.
- 7. Items billed directly to insurance companies will be reviewed monthly by the billing agency. Rebilling and additional information will be provided to the insurance company as necessary. After all appropriate insurance payments have been received a private statement will be generated and mailed to the patient if a legally collectable balance remains.
- 8. Payments will be made payable to the North Mason Regional Fire Authority but will be mailed to the billing agency's identified Post Office box.
- 9. Payments will be deposited directly into a bank account established by the Mason County Treasurers Office with copies of the deposit slip and the Treasurer's submittal mailed directly to the NMRFA. The billing agency will have "deposit only" access to said account.
- 10. Any overpayments or refunds to patients or insurance companies will be submitted to the NMRFA along with supporting documentation. Refunds by the NMRFA will be processed through the NMRFA's established voucher system.
- 11. As long as a patient has a private balance owing, they will continue to receive monthly statements until the account is paid in full or determined to be uncollectible. If the billing agency has received no payment and no contact from the patient after the second statement is mailed, they will attempt to make phone contact to encourage the patient to set up a payment plan. The billing agency will explain that there are no finance charges and even a small monthly payment will demonstrate the patient's cooperation in getting the account paid.
- 12. For those accounts that result in mail returned, phone disconnected, or no response, the billing agency will make a final call to the hospital to see if they have any updated information. Typically, these accounts have already been turned over to collections or written off by the hospital. If the patient received charity care from the hospital a NMRFA charity care application will be mailed to the patient. In the rare situation that the hospital has new billing information the billing agency will follow up with this information. If no further information is available from the hospital, these accounts will be deemed uncollectible.
- 13. For those guarantors owing \$100 or more, (who are not deceased or on Medicare part B), who have not responded to the mailing of the fourth statement, a collection notice is sent with the fourth and final statement. This notice includes a date by which the patient must respond to avoid collections. If no response is forthcoming, the account is then turned over to Fairway Collection Services for follow up and adjustment off the accounts receivable. If we have no correct address, the account is sent directly to Fairway Collections without this notice. A 40% collection fee will be added to all collection accounts in an effort to offset collection service costs. Those accounts of

less than \$100 are adjusted off the accounts receivable. A list of the patients deemed uncollectible is available in the monthly reports sent to the NMRFA by the billing agency.

- 14. If a patient returns a charity care application to the billing agency office it will be forwarded to the NMRFA EMS Officer and any other patient information they have regarding the account, with a billing agency recommendation. The EMS Officer will review all applications, information and recommendations. Following a review the EMS Officer will be tasked with either approving or denying all charity care applications. A signed authorization will be sent from the NMRFA to the billing agency granting the appropriate charity care.
- 15. Once a month after the final charges for the month have been entered a month end process will be performed. The process will generate the monthly private statements, ages the accounts receivable and produces a summary report for the NMRFA detailing the monthly activity.
- 16. The NMRFA will meet annually with the billing agency staff and follow their recommendations on establishing fees and procedures that will maximize insurance company reimbursements. The Fire Chief will be authorized to follow billing agency staff recommendations.

#### PURPOSE

To reimburse the NMRFA for the extraordinary costs associated with the response to DUI incidents.

# POLICY

In the event that NMRFA personnel and equipment respond to a DUI incident caused by an individual who has been found guilty or has had their prosecution deferred while driving under the influence of intoxicating liquor or any drug, the NMRFA will seek cost reimbursement for response costs.

The NMRFA will use the Washington State Fire Chief's Reimbursement (WSFCR) Schedule to determine appropriate costs.

# PROCEDURE

Immediately following a DUI incident response an incident report will be completed by the officer on duty. The report will identify amount, type and time that NMRFA resources were used including personnel and equipment. This report will be forwarded to the Chief for review.

The Fire Chief will determine if cost reimbursement is appropriate for the Fire Authority's response. The Chief will prepare an invoice seeking cost reimbursement following the WSFCR. At minimum the invoice will itemize the quantity, amount, and type of resources used. The Chief will then send the invoice to the responsible party for reimbursement.

The Fire Authority will send two invoices seeking reimbursement. If cost reimbursement is not received within 15 days following the second invoice the Fire Authority will send the reimbursement invoice to an established collection agency. The Fire Authority will add a 40% fee to recoup the costs associated with collection services.

#### SCOPE

All Authority personnel

#### PURPOSE

To reimburse the Authority for the extraordinary costs associated with hazardous materials response

#### POLICY

In the event that Fire Authority personnel and equipment respond to a hazardous materials incident, the Fire Authority will seek cost reimbursement for all extraordinary response costs.

Extraordinary response costs include costs that exceed the normal and usual expenses anticipated for fire protection and emergency services including, but not limited to, overtime, extra fuel consumption, loss or damage to Authority equipment, and the purchase or lease of any special equipment or services required to protect the public during a hazardous materials incident.

The Fire Authority will use the current Washington State Fire Chief's Reimbursement (WSFCR) Schedule to determine appropriate costs.

#### PROCEDURE

Immediately following a hazardous materials response an incident report will be completed by the officer on duty. The report will identify amount, type and time that Fire Authority resources were used including personnel and equipment. This report will be forwarded to the Assistant Fire Chief for the quantity, type, and amount of Fire district resources used for review.

The Fire Chief will determine if cost reimbursement is appropriate for the Authority's response. The Chief will prepare an invoice seeking cost reimbursement following the WSFCR. At minimum the invoice will itemize all resources used, time used, and the cost for each. The Chief will then send the invoice to EF Recovery for reimbursement collection. EF Recovery–will send two invoices seeking reimbursement. #### SCOPE

All department personnel

#### PURPOSE

To reimburse the NMRFA for the cost(s) associated with the suppression of fires that are started without a permit.

#### POLICY

In the event that Fire Authority personnel and equipment are used to suppress fires that are started without a permit the Fire Authority will seek cost reimbursement for such work.

The Fire Authority will use the Washington State Fire Chief's Reimbursement (WSFCR) Schedule to determine appropriate costs.

#### PROCEDURE

Immediately following a non-permitted fire requiring Fire Authority suppression resources, a fire incident report will be completed by the officer on duty. The report will identify the quantity, type, and amount of Fire Authority resources used including personnel and equipment. This report will be forwarded to the Fire Chief for review.

The Chief will then determine if cost reimbursement is appropriate for fire suppression efforts. The Chief will prepare an invoice seeking cost reimbursement following the WSFCR. At minimum the invoice will line item all resources used, time used, and the cost for each. The Chief will then send the invoice to the responsible party for reimbursement.

The Fire Authority will send two invoices seeking reimbursement. If cost reimbursement is not received within 15 days following the second invoice the Fire Authority will send the reimbursement invoice to an established collection agency. The Fire Authority will add a 40% fee to recoup the costs associated with collection services.
